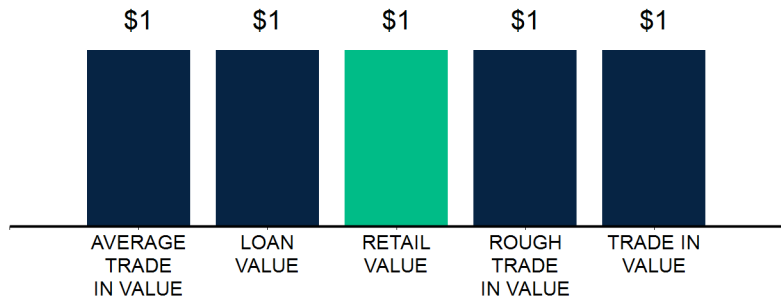

**Summary** Harley-davidson motor company (harley-davidson) is recalling certain model year 2016 electric glide ultra classic (flhtcu), electra glide ultra classic low (flhtcul), ultra limited low (flhtkl), ultra limited (flhtk), cvo street glide (flhxse), street glide (flhx), street glide special (flhxs), road glide special (fltrxs), road glide (fltrx), police electra glide (flhtp), road glide ultra (fltru), fat boy s (flstfbs), softail slim s (flss), and cvo softail pro street breakout (fxse) motorcycles. In the affected motorcycles, the clutch master cylinder may lose the ability to generate enough lift to disengage the clutch, especially if the motorcycle has been parked for an extended period of time.

The National Motor Vehicle Title Information System (NMVTIS) is an electronic system that contains information on certain automobiles titled in the United States. NMVTIS is intended to serve as a reliable source of title and brand history for automobiles, but it does not contain detailed information regarding a vehicle's repair history.
